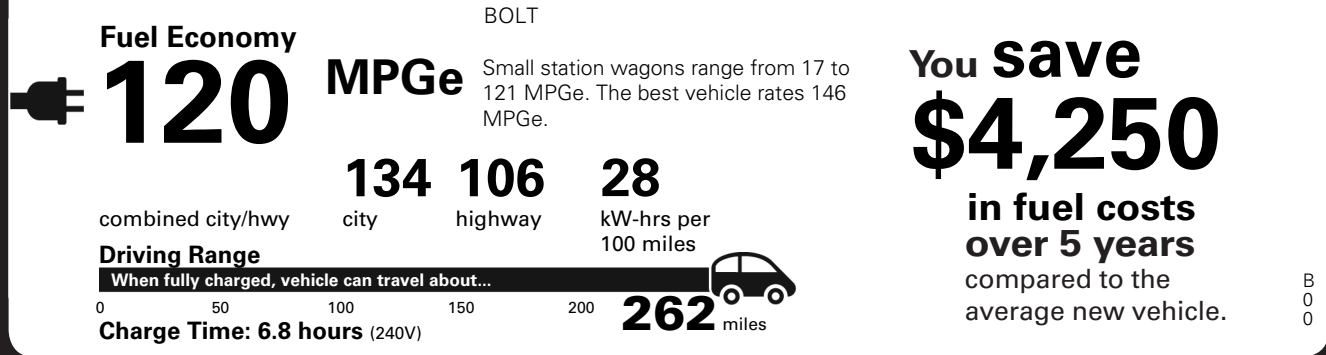

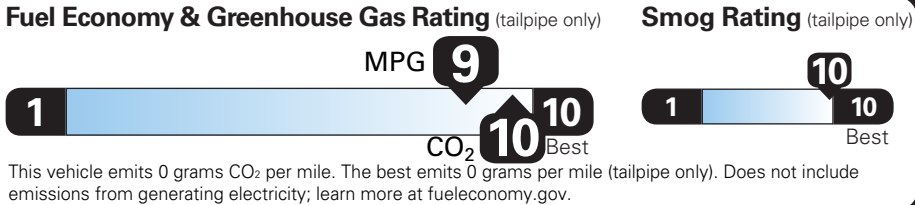
EPA DOT Fuel Economy and Environment
