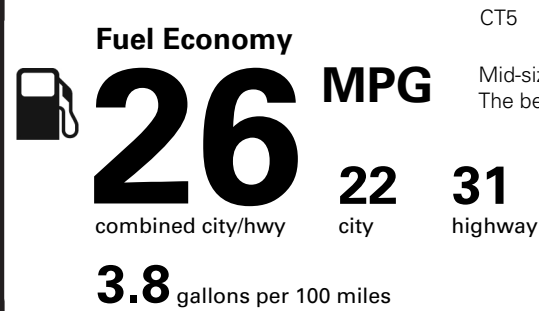

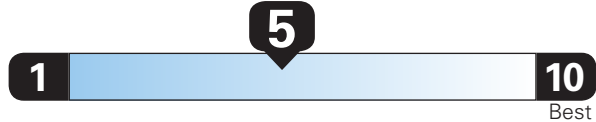
Gasoline Vehicle



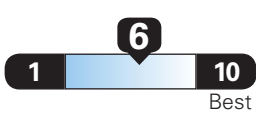
