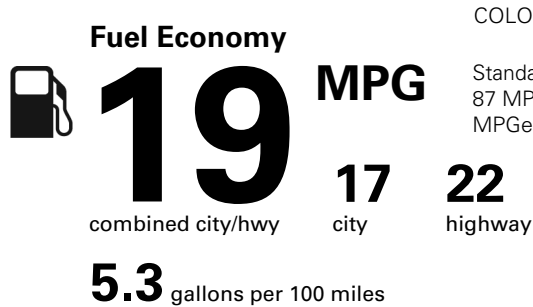

Gasoline Vehicle

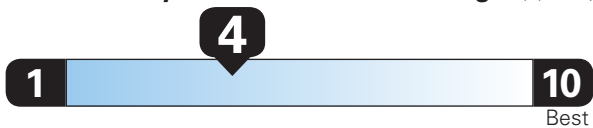

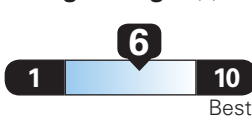
