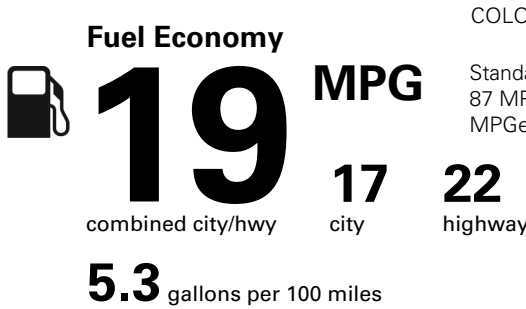

Gasoline Vehicle

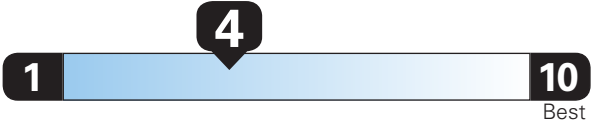

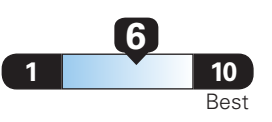
