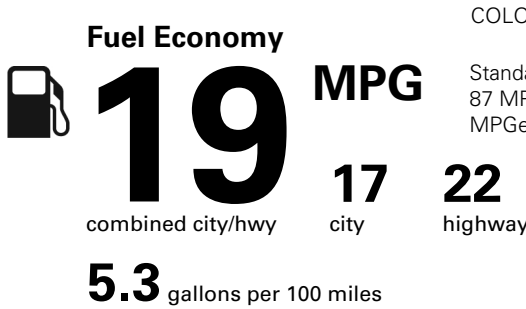

Gasoline Vehicle

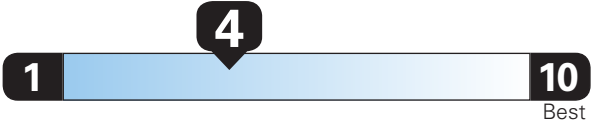
