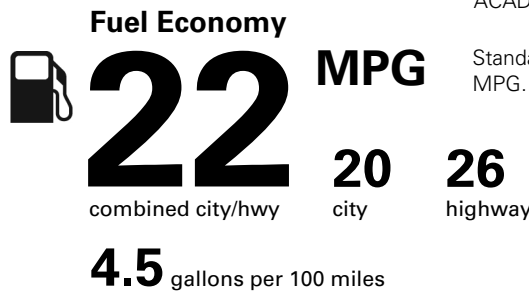

Gasoline Vehicle

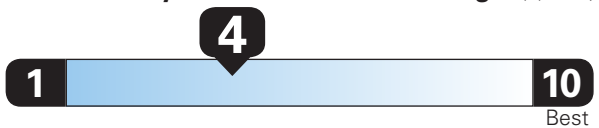
