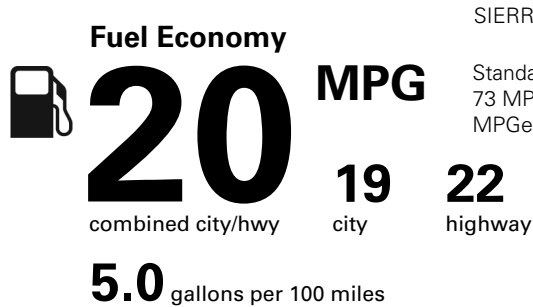

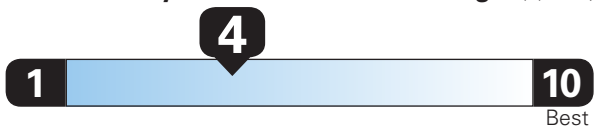
Gasoline Vehicle



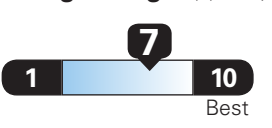
