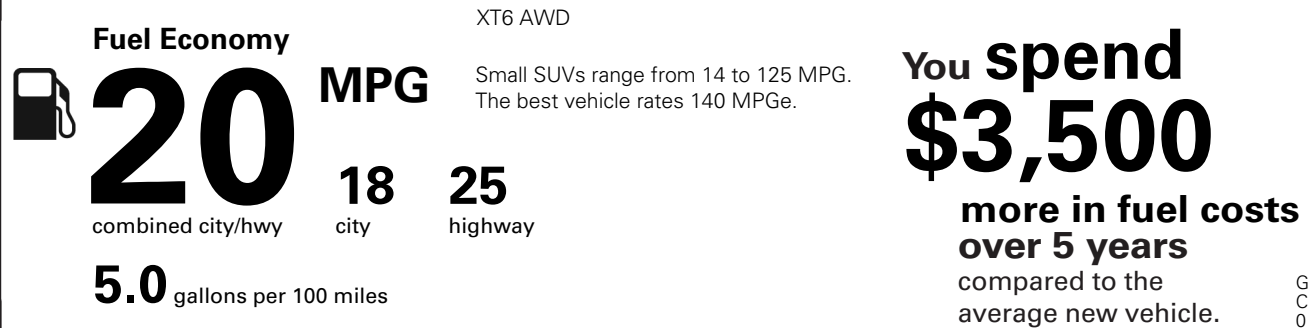

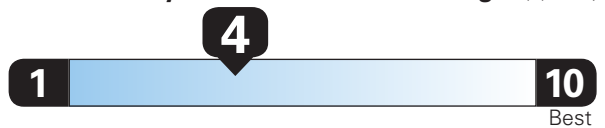


Gasoline Vehicle

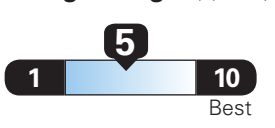
