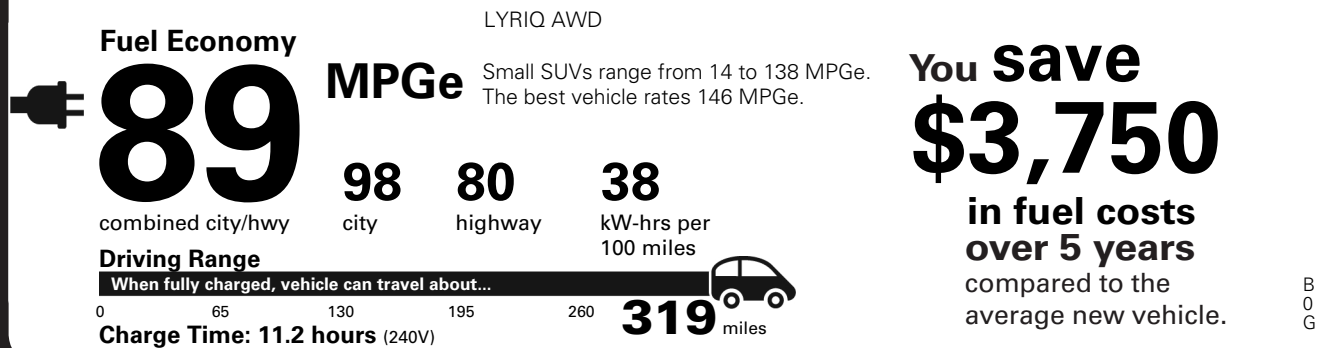

Electric Vehicle

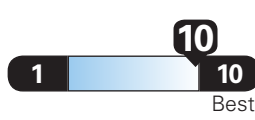
