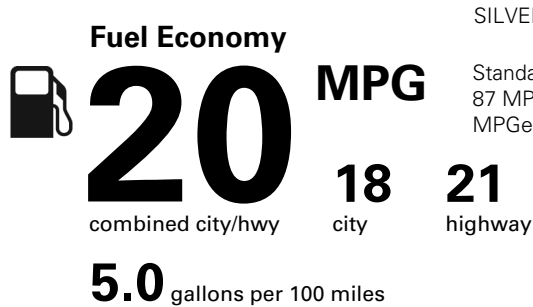

Gasoline Vehicle

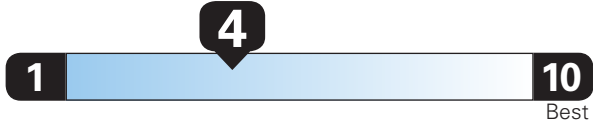

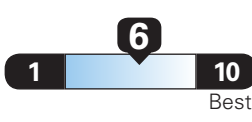
