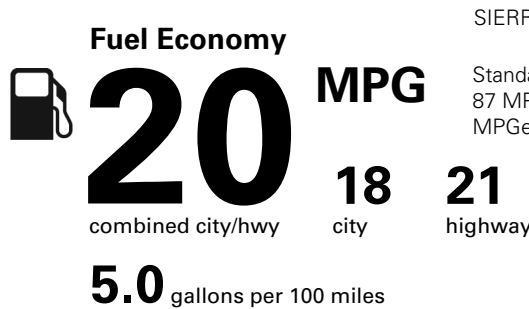

Gasoline Vehicle

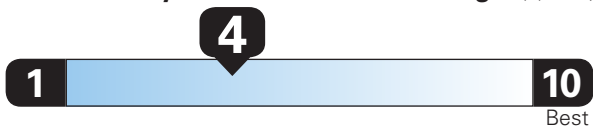

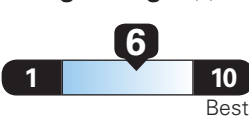
