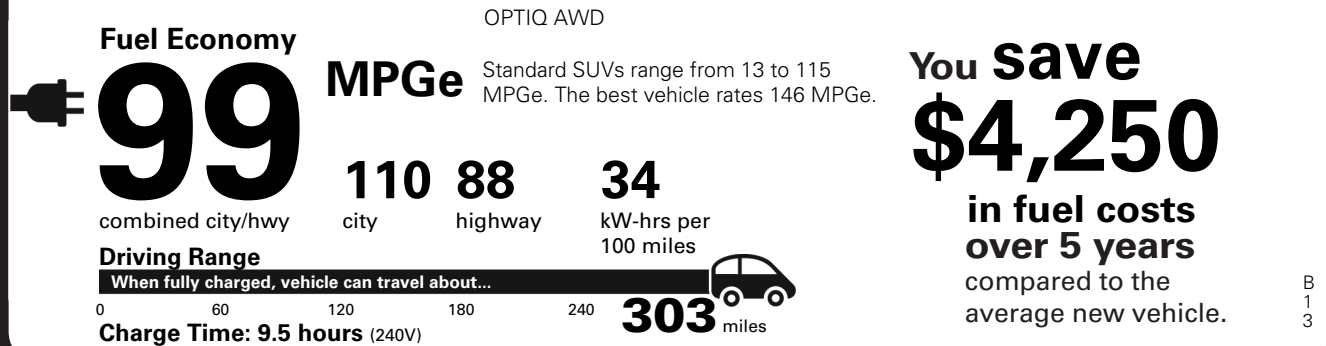

Electric Vehicle



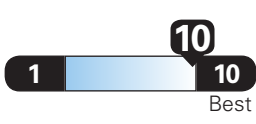
