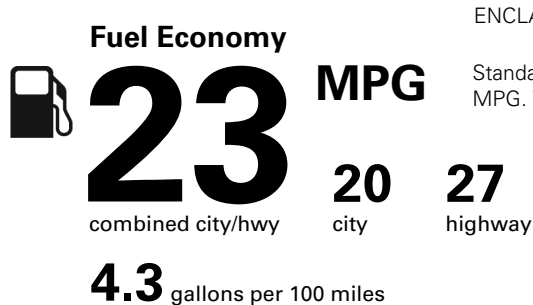

Gasoline Vehicle



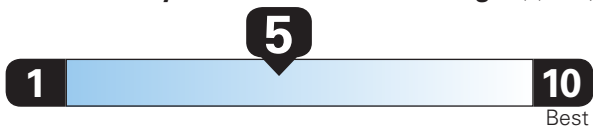
